## 3. Presentation, negotiating and communication skills

#### **Entrance Requirements**

This programme is for practising lawyers who already have an high level of English and who wish to improve their proficiency to equip themselves to work with, and for, international clients. Written applications will be followed by a telephone interview in order to understand the specific learning needs of each candidate as well as their suitability for the programme. Those participants who are selected, will be asked to submit a short learning objectives survey in advance of the programme.

#### Fees

The participation costs are:

- Registration fee payable at the time of application of 450€
- The course fee including teaching and all materials for the full two week programme (more details below)
- Meals and private ensuite accommodation at Churchill College Cambridge of 860€.

There is an **Early Bird discount** if registration fee is made prior to **Friday 7th May 2010**.

#### **Accomodation and Facilities**

The course will be held at Churchill College Cambridge. Participating students will have their own private room at Churchill College and be provided with full board – breakfast, lunch and a buffet dinner each night.

#### Certification

A Certificate of Attendance will be given to those who attend a sufficient number of lectures. Where requested by a sponsoring organisation, tutors can provide feedback on participants' learning with their express consent. At the conclusion of the course, students will be advised as to their preparedness to sit the subsequent ILEC examination on 18th September 2010.

#### **Evening Activites**

If there is demand we will arrange for special nighttime catch-up study sessions. Attendance at these sessions will be entirely optional. There will also be a number of social events recommended for the duration of the course such as concerts and night-time excursions.


